By your signature below, each entrant, or in the case of an entrant under the age of 18 years of age, the parent/guardian of each entrant, hereby agrees, understands, represents, and accepts the following:

I am either 18 years of age or older, or I am the parent/guardian of the person you are registering to participate in this event. Additionally, if the child I am registering is under the age of 13, I am consenting to the collection and use of the information about the child for the purpose of the registration as described in our privacy policy.

In consideration of West ISD's acceptance of this entry, I, for myself, my heirs, executors, administrators and assigns, forever release and discharge any and all rights, demands, claims for damages and cause for suit or action known or unknown, that I may have against West ISD and its administrators, staff, and employees for any and all injuries in any manner arising or resulting from my participation in said race. I attest and verify that I have full knowledge of the risks involved in the race. I agree that I am solely responsible for determining if I am physically fit and/or skilled for the race or activities. I attest and verify that I will assume and pay my own medical and emergency expenses, and that I am physically fit and sufficiently trained to participate in this race. I release the rights to any and all photographic material and computer information West ISD may wish to release for this event without obligation to me.

I understand that participating in a "Color Run" is a potentially hazardous activity where colored powder will be thrown at and around me during the course of the event. I understand that some of the course I, the participant, may go through colored powder, which has not been tested for chemicals or disease. I agree not to participate unless I am medically and physically able, which I am solely responsible to determine. I assume all risks associated with participating in the "Color Run", including, but not limited to, slips, falls, contact with other participants, negligent acts of other participants, any defects or condition of premises, or color zones, the effects of the weather including but not limited to high heat, cold temperatures, storms, snow, ice, rain, and/or humidity. All such risks being known assumed and appreciated by me. I assume risk of wild animals and insects that may be present on the course. I agree to indemnify West ISD from any and all third party claims caused in whole or in part by my actions. I agree that West Independent School District and its board and committee members are not responsible for any personal items or property that are lost, stolen, stained or damaged at or during the event. I understand and agree that pets are not permitted to accompany me in the race, and children under the age of 18 are not permitted to participate in the race unless a parent or guardian signs this waiver on their behalf. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment and facilities and cooperative, positive participation.

I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims. PARTICIPATION WILL BE DENIED, if I have not signed this waiver before the start of the event.
